

HUTCHISON PORTS ECT DELTA

Europaweg 875, Havennummer 8200, 3199 LD Rotterdam (Maasvlakte)

As you are (or will soon be) our guest at Hutchison Ports ECT Delta, we would like to ask your attention for the important information below.

ROUTE TO THE ECT DELTA TERMINAL

The ECT Delta terminal is easy to find: simply follow 'havennummer 8200' (port number 8200) on the signposting in and around Rotterdam. The full address is listed in the blue text above. Some navigation systems will not provide the shortest route to the ECT Delta terminal as they are unfamiliar with the numbering system on the Europaweg (they will advise you to prematurely exit the A15 motorway). Make sure to check this beforehand or only make use of the port numbering system.

Attention! Please make sure to factor in extra travelling time. The ECT Delta terminal is located at the Maasvlakte, some 45 minutes by car from downtown Rotterdam. Registering at the security lodge and driving to your destination at the terminal will require extra time as well.

REGISTRATION

You and any passengers in your vehicle will need to register at the security lodge, which has temporary parking facilities. The security officer has already been

notified of your visit by the person you have an appointment with at the terminal. You are required to identify yourself by means of a valid ID and show a registration certificate for your car.

After you have successfully completed the safety instruction (see box), the security guard will refer you to the location of your meeting.

The security officer will refer you to the location where your meeting will take place. Below is the route that will take you to the building in question.

Our buildings do not have a reception desk, so make sure to carefully follow the instructions of the security officer as regards the building number, floor and office number. Children and/or pets are not allowed to enter the terminal.

ECT PREMISES

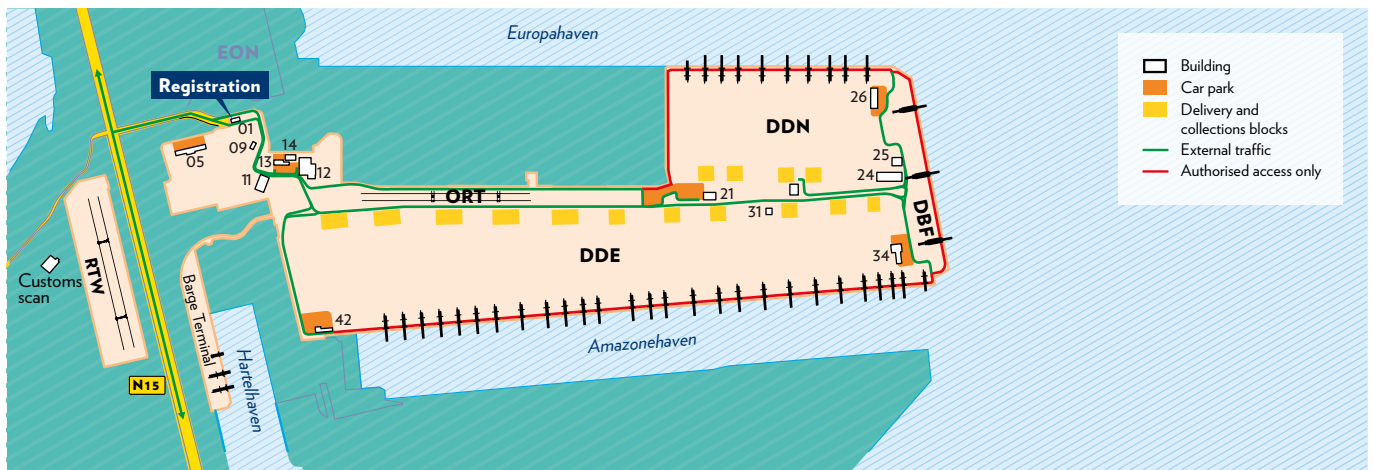
Whenever you are on ECT terrain, you must adhere to the safety rules and code of conduct of ECT, which include:

- the maximum speed on through roads is 50 km/hour; in the operational areas

MANDATORY SAFETY INSTRUCTION

For your safety, it is mandatory to complete the safety instruction via <https://ect.toegangbeheer.com>. We request that you do this prior to your visit to prevent delays at the security lodge. Following successful completion, the instruction remains valid for two years. This means you do not need to complete the instruction for every visit.

- (prior authorisation required), the maximum speed is 30 km/hour;
- follow the route marked in green below to your destination building and be alert for all other (freight) traffic; **Caution! The quay is an operational area and is off-limits without proper authorisation!**
 - you have to park your car at the designated parking spaces;
 - when entering or leaving the ECT terrain and building, you are obliged to cooperate with any searches;
 - smoking is only permitted in designated smoking areas;
 - consuming and/or possessing and/or transporting alcoholic beverages, drugs and/or hallucinogens during your visit is prohibited unless medically prescribed.
